< Hamura Nigiwai Shopping Voucher 2017 ~ Advance Sale for Elder, Handicapped,</p> Pregnant People, or Child Rearing Households >

Hamura residents who are eligible for placing a pre-order of the advance voucher sale can purchase up to 3 voucher books per person during the designated advance sale period.

You pay **¥10,000** per voucher book, and you get Face Value of **¥11,000** per book (¥500×22tickets) <u>Eligibility</u>: *Hamura* resident (as of Feb.19th, 2017) who is over 75 years old, owns a *Shougaisha Techou* (handicap certificate), pregnant who owns a *Boshi Kenkou Techou* (Maternal and Child Health Handbook), or is household raising a child at age junior high school or younger.

<u>Availability</u>: 3,000 voucher books reserved for special advance sale. *If more people apply over the limit, selections will be made by lot-drawing. The result of the lot-drawing will be mailed to all applicants using the reply post card. The post card you receive will be the ticket for buying the advance reservation voucher. January 26th is Cultural Heritage Fire Prevention Day. A valuable mural of the temple in Nara Prefecture was lost to a fire which occurred on January 26th of 1949. Awareness to protect assets started from this incident, which led to the Cultural Heritage Asset Protection Law to be enacted in 1950. In observance of this Law, the first Cultural Heritage Assets Fire Prevention Day was established on January 26, 1955.

To allow time for data imput, you must anticipate a 30 minute waiting time when coming to file taxes.

*a combination of inhabitants taxes paid to local municipality and prefectural government, calculated based on your total income of the preceding calendar year.

Who has to file the Residents Tax Return?

- Persons whose only income source was the employment income, and his/her <u>employer did not file</u> the salary/wage payment report (*Kyuuyo Shiharai Houkoku-sho*) to the municipal office.
 - *Please confirm about the filing system of your workplace(s) that you worked for in the previous year.
- Persons who had any Business Income, Real Property Income, Income from Dividends, income from public pension or any other type of income, and who are not required to file the income tax return.
- Persons who had any tax-free income. (Benefits from survivor's pension, disability pension, unemployment insurance, livelihood protection)
- Persons who had no income. (No need to file if registered dependent under other Hamura city resident)
- owns business but lives outside of Hamura city
- Subscribers to National Health Insurance or Long Life Medical Care Program who did not have any income (You will not be required to files taxes if you are filing income tax return (kakutei shinkoku), if your employer has handled your tax return, have income less than ¥1,515,000 in pension at 65/older, or are a dependent.)

What to Bring for Filing the Tax Return

There is no need to fill out the Tax Return form beforehand. Please have applicable documents ready.

- Tax Return form Inkan (Do not use the casual rubber stamp. Use personal seal.) Resident Card
- Documents proving your income record of 2016 (Certificate Of Income And Withholding Tax 源泉徴収票, or official record of any income you are declaring) for yourself and for your dependents.
- A Pension Beneficiary should bring Certificate of Income with pension indicated (Certificate Of Income And Withholding Tax 源泉徴収票)
- National Pension Deduction Certificate (国民年金控除証明書)
- Deduction for Social Insurance Premiums: Deduction for the following categories of payments paid in 2016: Please attach the stamped receipts of payment and necessary documents for the application of deductions.
 - ► National Health Insurance Tax Premium (国民健康保険税), Late-Elderly Medical Insurance Premiums (後期高齢者医療保険料)/health coverage (健康保険料), Welfare Annuity Provided by your employer (厚生年金保険料)
- Deduction for Life Insurance Premiums and Earthquake Insurance
 Please present your Insurance Premiums Deduction Certificate (保険料控除証明書) provided by mail from the insurance company.
- Deduction for Medical Expenses: receipts issued by doctors, detailed statement of medical expenses, etc
- Tax credits may be applied for various donations (Present receipt issued to you)
- For Person claiming Disability related deductions: Please present physical disabilities certificate, or certificate for mental deficiency(身体障害者手帳、愛の手帳).
- Special Spousal Deduction: Please attach a document certifying the spouse's income.

- Statement of Earnings and Expenditures (in case of earners of business income / real property income)
- Official documentation required for personal spousal exemptions for relatives residing overseas
 - ▶ Documents Providing Proof of Kinship an accurate translation
 - ▶Financial Documents proving bank remittance for supporting the dependent and an accurate translation
- Individual Number Card (my number card), or Individual Number Notification Card (tsuuchi card) and ID

NOTICE TO THOSE LEAVING JAPAN DURING 2017

A person departing from Japan (who cease to have resident address in Japan) must declare his/her income well before departure, and designate a tax agent who will handle the tax-related correspondences and tax payments in Japan on behalf of a client. Please note that individuals who have not paid their tax or filed a return by the specified due date may be imposed delinquent tax.

For more information, please refer to Income Tax Guide for Foreigners available online.

This issue of *Hamura* News provides a brief guideline and basic instruction on income tax return. (Foreign residents should confirm with their embassies/consulates for details on any bilateral tax treaties which may affect income tax collection/reporting here in Japan and back home.

◆ Cases of Final Tax Return that cannot be handled at city hall ◆

Inquiries which require technical interpretation of tax laws, such as those relating to Income from Capital Gains Subject to Aggregate Taxation ($Jouto\ Shotoku$) and returns dating back to 2015 cannot be answered at city hall. Please take those inquiries directly to National Tax Agency $\bar{O}me$ Office.

◆ Free income tax consultation is provided by Ōme Tax office and Tokyo Regional Taxation Bureau.
Free income tax and resident tax consultation are also provided at Hamura city hall 4th floor, Daikaigi-shitsu on the following dates. Feel free to stop by to get help from professionals before filling out your return form.

February 8th (Wed) ~ March 15th (Wed)

Monday ~ Friday, 9AM~11AM & 1PM~3:30PM Closed on Weekends and Holidays

Tax consultants from $\bar{O}me$ Tax Office will be available to answer questions regarding certain cases of final return that are usually not handled at city hall on February 13th (Mon) ~ 15th (Wed) (until 3PM).

Kanpu Shinkoku (Refund Return) - Application for Tax Refunds

The filing period for the income of 2016 has already started at $\bar{O}me$ Tax Office.

You can apply for Tax Refunds if your income tax has been withheld at source from your salary/wage of 2016 and you expect you have over-paid income tax, or you have not undergone year-end adjustment (or *Nenmatsu Chousei* in Japanese, is usually processed by the employer.) with the payer of your salary/wage and you are eligible to receive tax allowance / tax credit, etc.

What to Bring for Filing the Tax Return

Please refer to the section with this title on the previous chapter of the Residents Tax Return (*Jyuminzei no Shinkoku*) page. The necessary documents are the same.

- *The parking spaces of $\bar{O}me$ Tax Office will not be available (spaces for disabled people are available) from February 1st (Wed) to March 31st(Fri).

Filing via Internet

"e-Tax" online tax filing and payment system allows taxpayers who have electrical identification certificate (Kouteki Kojin Ninshou) to file income tax return and pay tax online. •e-Tax Help Desk: \$\infty\$0570-01-5901 (An IC card reader for your PC and user registration are also needed in advance to use the service.)

Those who obtained the electrical identification certificate number for e-tax purposes, and filed for tax online previously, will not receive tax return forms by mail.

Social Security, Tax Number System is required for administrative procedures.

The Individual Number Card (my number card), or Individual Number Notification Card (*tsuuchi card*) and valid identification, such as a driver's license, resident card, or passport must be presented with the documents related to your tax return.

• Tax Deductions for persons in need of nursing care

Persons who have 要介護/要支援認定 Youkaigo/Youshien Nintei (Certification of Needed Long-Term Care/Support) and persons who have a dependent with this certificate can apply for Exemption for the Disabled. Please obtain Certificate for the Exemption for the Disabled (障害者控除対象者認定書) at city hall. Those 65 years old or older who have severe degree of disability, and are certified under the long-term care needs will be eligible for tax exemption certification under the measure. There are many categories and conditions regarding level of severity for above certification which apply, so please inquire at 含素 177

Fees for nursing care services that are subject to the Nursing-care Insurance Coverage: Current nursing care facility users may be applicable for medical exemptions of fees incurred. Certain conditions apply, so please inquire at *Kourei Fukushi Ka, Kaigo Ka, Kaigo Hoken* Section at **E**Ext.142 regarding the Nursing Care Insurance System, or the *Ōme* Tax Office about general inquiries about method and policy of tax system (*Ōme Zeimusho*) **2**0428-22-3185.

If you apply to receive tax deductions for Long-Term Care Insurance Premiums, please ask the $\bar{O}me$ Zeimusho 20428-22-3185 on detailed instructions. If you will be requesting the Patient-Borne Expense Ceiling Amount Certificate for Long-Term Care Insurance, please inquire at Kourei Fukushi Ka, Kaigo Ka, Kaigo Hoken Section at 20428-22-3185 Ext. 142.

Expenses for adult diapers prescribed by a doctor are subject to the Deduction for Medical Expenses. Certifications by a physician may are required under the policy if you have been a recipient of 2 years or more. Please contact *Kourei Fukushi Kaigo-ka, Kaigo Nintei Kakari at* Ext. 146.

Nursing Care Prevention / Overall Support Project for Sustaining Quality of Daily Life for Elders

The revision to the Law Pertaining to Long-Term Care will become effective from April. The existing Nursing Care Prevention measures will be combined with newly established portion, the Elder Citizens Nursing Care Prevention aimed to sustain livelihood of those 65 years or older, expanded to provide overall support. There are two parts to the project:

- Nursing Care Prevention/ at home or out-patient nursing and personal care services
- General Nursing Care Prevention

<u>Nursing care prevention / nursing personal care services</u> refers to those services utilized either from an at-home or out-patient service offered by certified facilities for preventing further deterioration of physical and mental function by the elder who is certified as needing long-term nursing care level 1 or 2.

<u>General Nursing Care Prevention</u> focuses on sustaining bodily functions of the citizens at 65 years or older through exercise and promoting the participation in social activities. There will be more information soon.

Hamura City has been offering "Support for Advanced Training" in which there is support for expenditure necessary for living incurred by the single parent during the term while they are learning skills at an educational institution offering a skills course for a term of 1 year or longer for accreditation in the following certifications: nurse, childcare giver, and hairdresser. The term of support is limited to 3 years.

The "Loan for Advanced Training Offered to Enable Acquisition of Skills" which is a loan offered by the Tokyo Metropolitan Government, will start. It is a program established by the Social Welfare Association, which is offers financial assistance to the single parents to enroll into a professional training courses and for costs related to the employment. If they have been certified within one year, and continue the profession for at least 5 consecutive years, the debtor becomes exempt from their liability to pay back the loan under provision. *Prior consultation is required. -- To Prevent Disaster -

Weather forecasts can be useful in determining the severity of circumstances from predicted amount of snowfall. There are preventive measures which can be taken.

- Be prepared Buy a shovel before the store runs out of stock.
- Structural support such as long objects installed in the shed or garage type structures can avoid collapse.
- Finish your grocery shopping prior to the worsening of weather conditions.
- Also useful are the information from the *Hamura* City, and other television and radio broadcasts which will inform you of road closures and necessary emergency information.

-- If it Snows -

- Avoided leaving your home. If you must go out, stay calm. Wear durable shoes.
- Have snow gear for your vehicle, and keep your distance from the car in front of you, and don't speed.
- Beware of the snow which falls from rooftops and trees.

-- Guideline for Snow Removal --

Please do not pile up snow near fire hydrants for it impedes the operations of the fire department.

The below listed guidelines should be followed as well:

- 1. Do not haul snow into the roadway section of the street.
- 2. Don't park illegally on the street.
- 3. Structures in the street set on the roadside to eliminate the level difference should be removed.
- 4. Please permit snow removal at night by the city hall. Noise levels may rise during the process. We may require road closures if necessary. Loading of snow into temporary residential spaces may occur.
- 5. Remove snow within reasonable area near the residence, such as driveways front and entrances areas.
