For those who will be 65 years old or older during fiscal year 2022 Subsidize taxi fare to COVID-19 vaccination site

Partial tax fare from home in the city or Hamura / Ozaku Station to the vaccination site (sports center) will be subsidized. "Taxi Subsidy Ticket" will be sent together with "Notice of Vaccination Date", please use it if you need to.

If you do not receive it, please inquiry to Hamura City COVID-19 Call Center. Eligibility:

- Those who will be 65 years old or older during Fascial 2022 year.
- Those who have registered Hamura resident.

Subsidy Amount: Amount exceeding ¥500 (own expense) per ride.

How to Use:

- ① Please ask the taxi designated by Hamura City to dispatch the taxi to you home in Hamura. Alternatively, take the train to Hamura Station or Ozaku Station.
- ② When you get on a taxi, give the driver "Taxi Subsidy Ticket" with your name, date of birth and vaccination number.
- ** If you do not have "Taxi Subsidy Ticket", please provide name, birthday and vaccination number to driver.
- ** You may use it in the same way when you return home from sports center (round trip will be costed ¥1,000 for your own expense).

新型コロナワクチン接種 追加接種(3回目の接種)を前倒しで行います

COVID-19 Vaccination ~ Booster (the 3rd) Vaccination will be performed ahead of schedule

In principle, COVID-19 Booster (the 3rd) Vaccination will be given 8 months or more after the completion of the 2nd Vaccination. However, in consideration of the outbreak of new mutant strains, the vaccination should be ahead of schedule as below list. In the city, vaccination to medical workers and residents of elderly facilities are given priority from January to February. Since March, the other elderly people will be vaccination as early as possible.

Sign and seal the tax return forms ~ "Deduction for spouse / dependent relatives" and "Applicable to the person". For those who did not have income in 2021, item [7. For those who did not have income], please fill in necessary items with documents and mail to address to:

*If the documents are enclosed, not need to enter the amount.

*If you need your copy of the tax return stamped with the date of receipt, and/or medical expense receipts returned, please enclose a duplicate copy of the form and a self-addressed return-envelope attached with necessary postage.

Note:

- ※ If you are member of the National Health Insurance or Elderly Medicare, please be sure to declare even not having any income during last year.
- * If you live together but different household on your resident certificate, please declare if you are dependent.

おむつに係る医療費控除について

<Medical expenses deduction related to Diapers>

Bedridden condition and diaper charges for those who need medical treatment are eligible for medical expense deduction. While filing your tax return, please attach the "Diaper fee receipt" and the "Using Diaper Certificate" issued by doctor.

Those who meet the following ① and ② can attach "Documents that the municipality has confirmed the contents of doctor's opinion" instead of "Using Diaper Certificate".

- Expenses for adult diapers prescribed by a doctor are subject to the Deduction for Medical Expenses. Certifications by a physician may are required under the policy if you have been a recipient of 2 years or more.
- ② People can confirm that there is a possibility of urinary incontinence in bedridden state by "Doctor's Opinion" at the time of certified nursing care.
- ** "Documents that the municipality has confirmed the contents of doctor's opinion" will be issued by Kourei Fukushi Kaigo Ka, Kaigo Nintei Kakari.

Re-Issuance of CERTIFICATE OF TAX DEDUCTION FOR SOCIAL INSURANCE PREMIUMS (For National Pension Insurance Premiums)

Certificate of Tax Deduction For Social Insurance Premiums (National Pension Insurance Premiums) 「社会保険料(国民年金保険料)控除証明書」 was issued by Japan Pension Service (日本年金機構) as a form of postcard, and mailed in early November to the National Pension Insurance Premium payers. National Pension Insurance Premium is tax deductible under a category of social insurance when necessary documents are submitted at the time of Year-end Adjustment or Final Return.

This certificate is a proof of the amount of your National Pension Insurance Premiums paid. Please request a

re-issuance of this document if you have misplaced it.
