

1 Ventilation

When it is cold, people always close doors/windows, but it is a good to open them from time to time to let the air circulate.

② Hand washing and fingers sanitizing



Wash your hands and disinfect your fingers with running water and soap after going out.

3 Cough Etiquette

When coughing or sneezing, wear a mask or cover your mouth and nose with a tissue or handkerchief. In medical institutions and facilities for the elderly, it is important to prevent infection among those who are at high risk of becoming seriously ill.

[Routine COVID-19 Vaccinations in progress]

Vaccination is reported to be effective in preventing the onset of the disease and the severity of the disease if it does occur. Vaccination is not mandatory. Please be sure to understand the effects and side reactions of the vaccine before receiving.

Term: Till March 31st (Mon), 2025.

Vaccination fee : JPY2,500.

<u>Eligibility</u>: For those who have a certificate of residence in the city on vaccine day and meet the following conditions ① or ②

- 1 65 years of age or older
- ② Those who are between 60 and 65 years old and have certain disabilities (equivalent to Level 1 of the Disabilities Handbook).
- * Those who fall under 2, must have a physical disability certificate or a doctor's certificate.
- * Those who do not fall under either ① or ② are not eligible for regular vaccinations, but may receive them on a voluntary basis. In such cases, the full cost of the vaccination is to be borne by the applicant.

Number of vaccination: One vaccination per person during the period

* Regardless of the number of times you have been vaccinated, you can receive one vaccination per person during the period.


